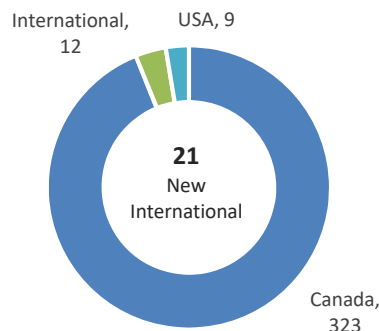

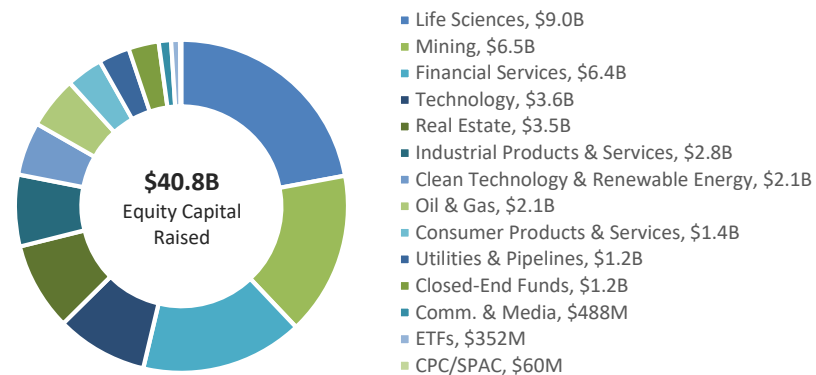

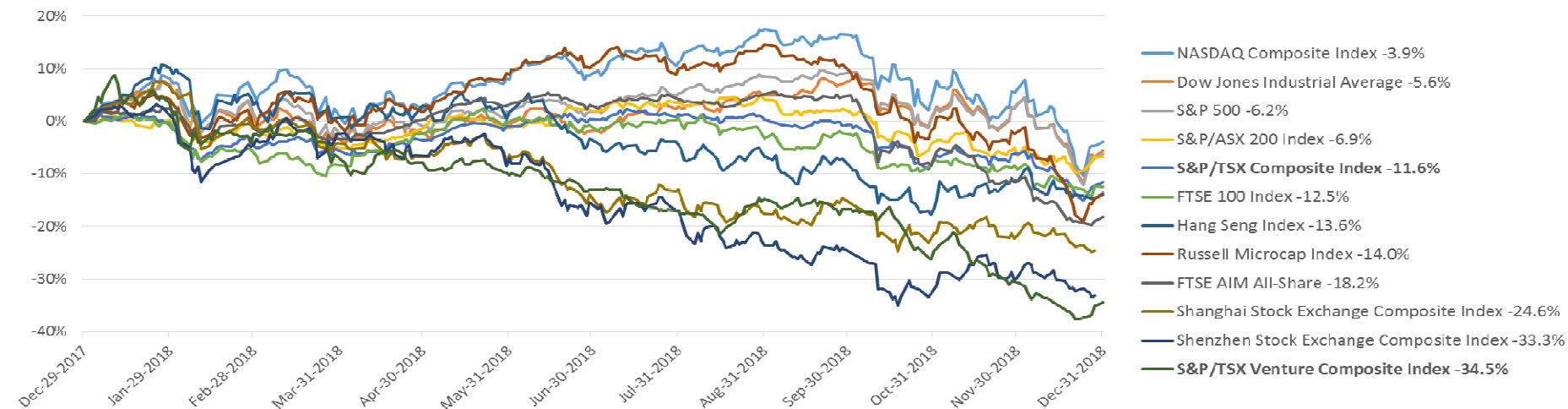

Comparison of Major Index Performance -- YTD December 31, 2018 (Source: S&P Capital IQ)

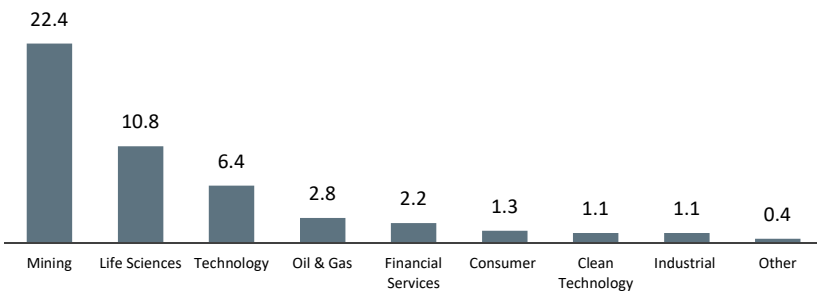

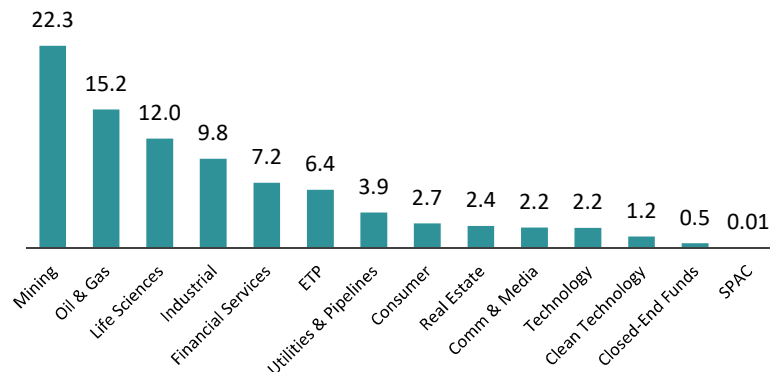
Volume Traded YTD December 31, 2018 on TSXV by Sector (Billions of Shares)
