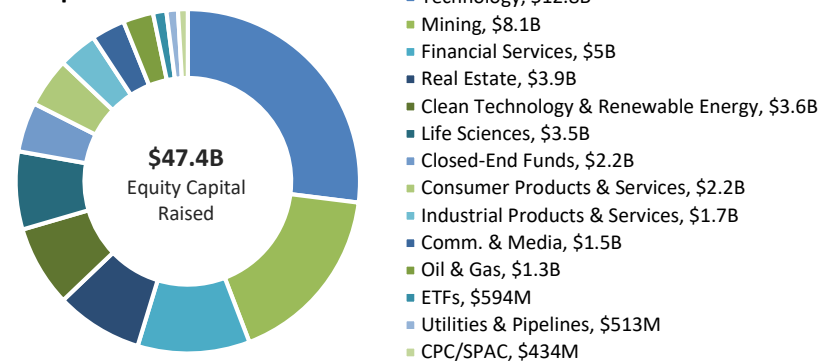

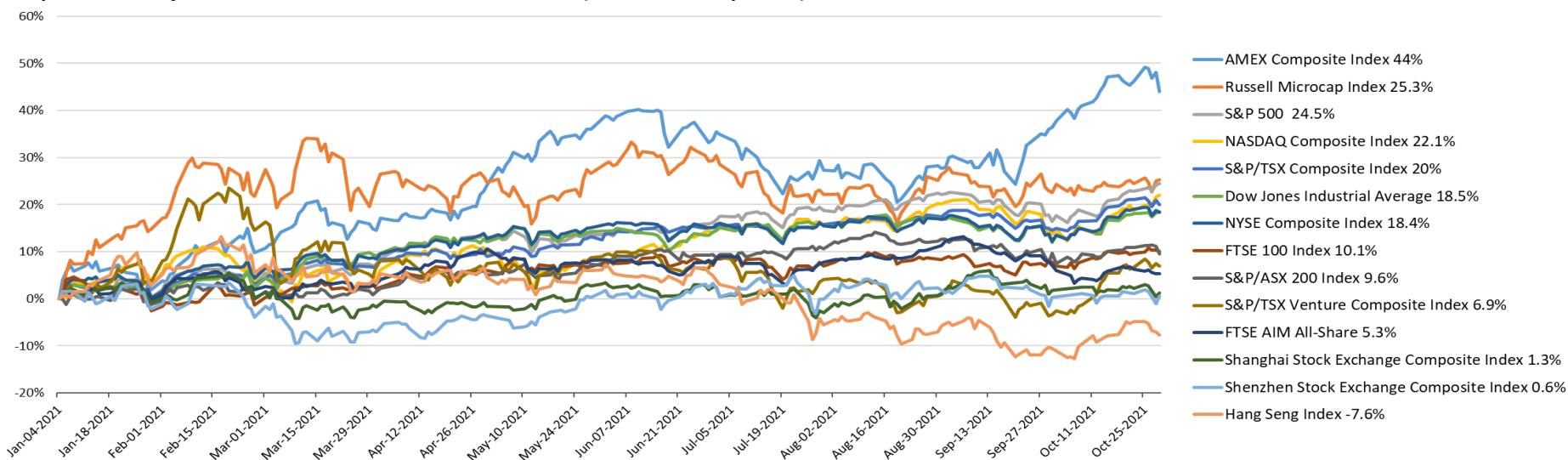

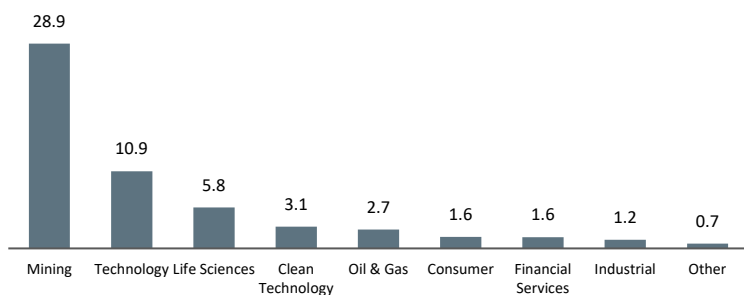
Comparison of Major Index Performance -- YTD October 2021 (Source: S&P Capital IQ)

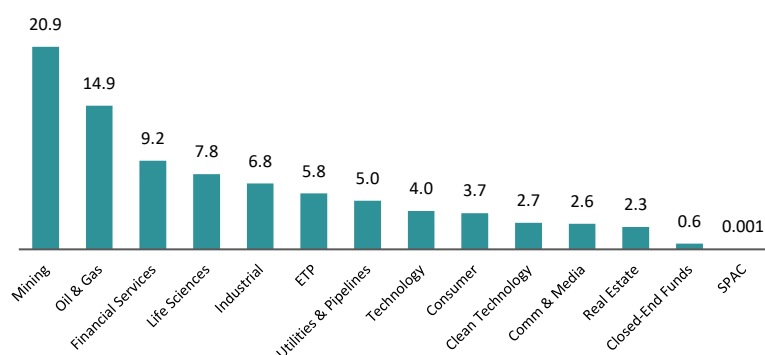
Volume Traded YTD October 2021 on TSXV by Sector (Billions of Shares)
