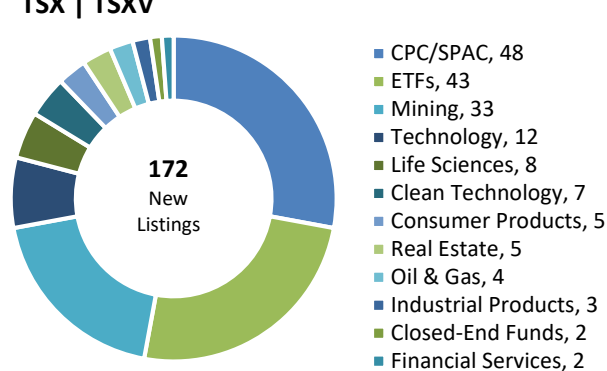

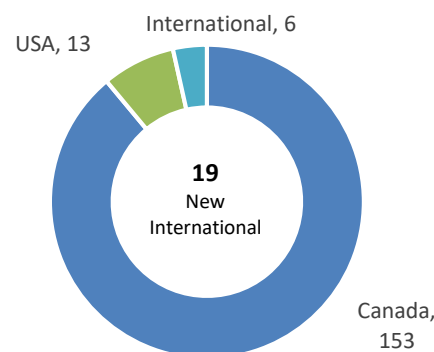

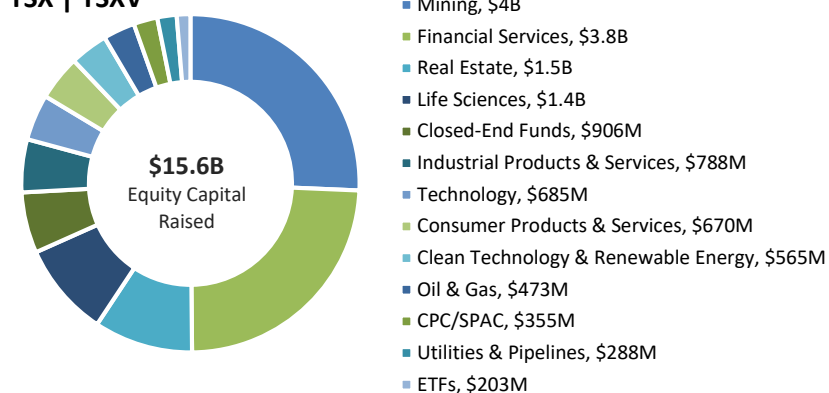

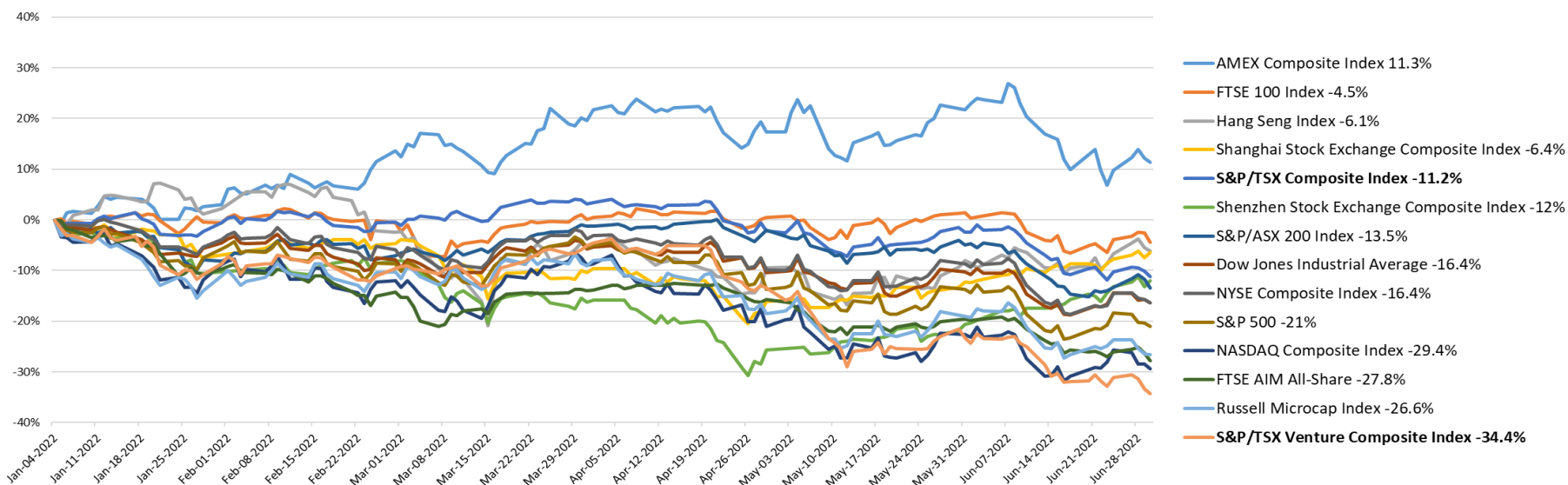

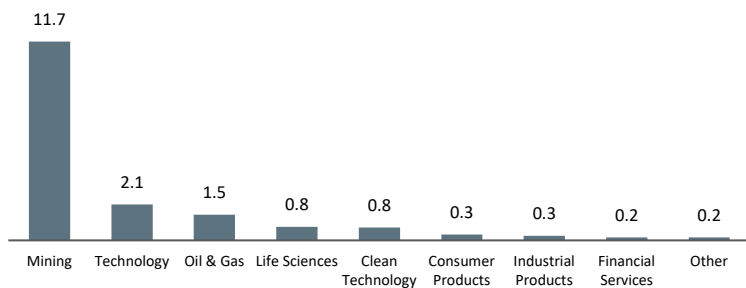
Major Global Index Performance -- YTD June 2022 (Source: S&P Capital IQ)

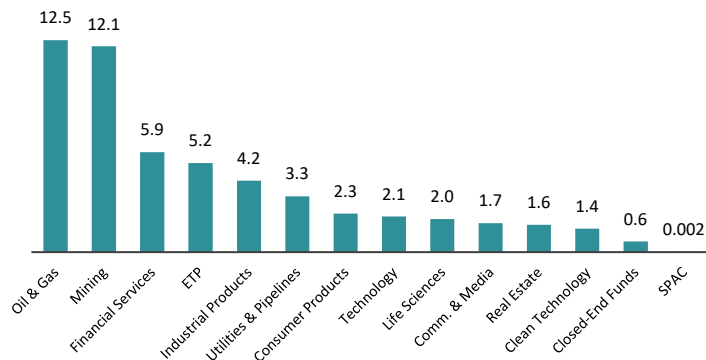
Volume Traded YTD June 2022 on TSXV by Sector (Billions of Shares)
