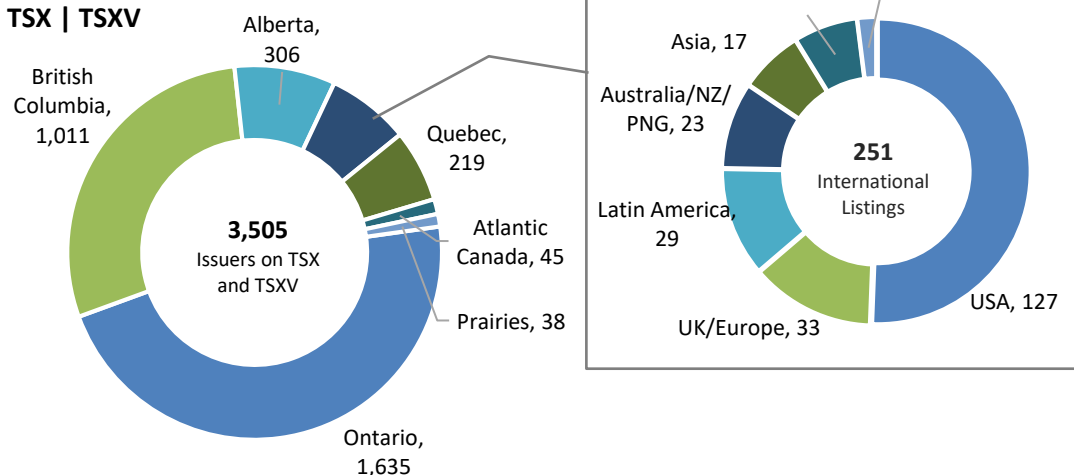

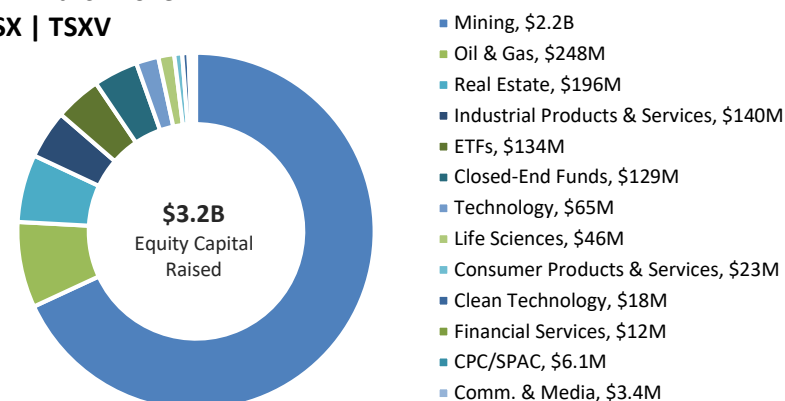

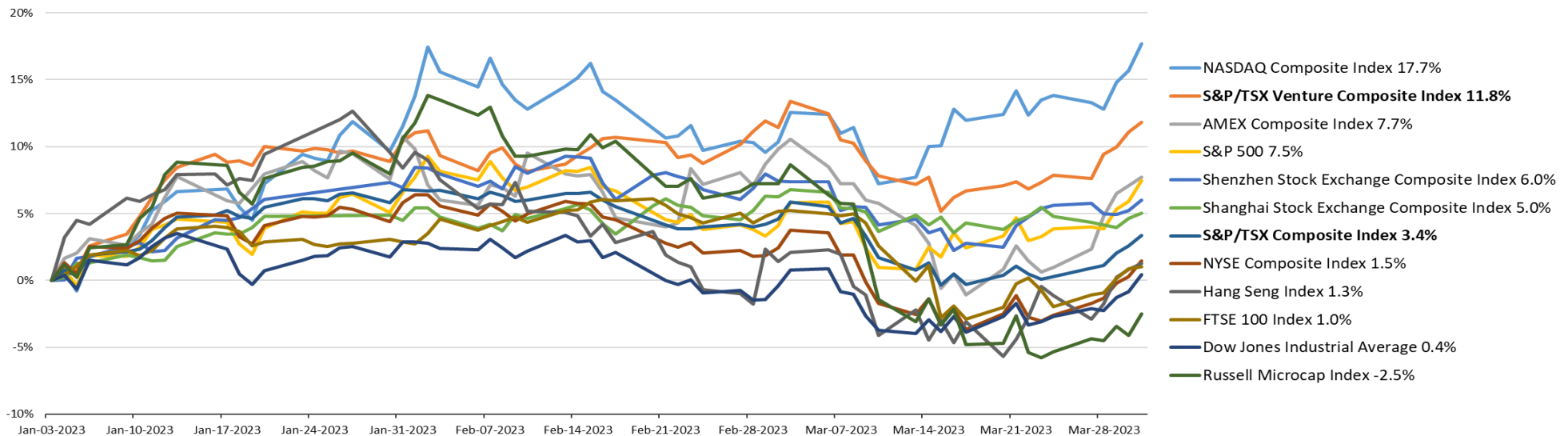

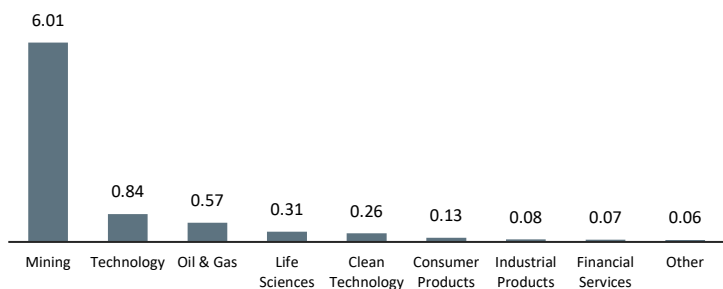
Major Global Index Performance -- YTD March 2023 (Source: S&P Capital IQ)

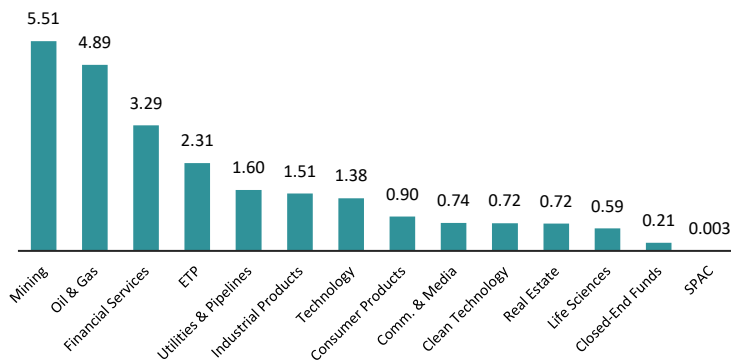
Volume Traded YTD March 2023 on TSXV by Sector (Billions of Shares)
